## Suppliers Confirmation - REACH

## (hereinafter referred to as "The Supplier").

The Supplier herewith confirms legally binding, that

- all the substances in products and in their packaging to be delivered by the Supplier to ABUS<sup>1</sup> comply with the regulation (EC) No. 1907/2006 of the European Parliament and the Council from December 18, 2006 concerning the Registration, Evaluation, Authorisation and Restriction of Chemicals (REACH),
- he undertakes to insure that the responsibility that the substances on their own, in preparations or in products which are subject to pre-registration / registration under the REACH Regulation delivered by the Supplier starting from the 1st of June 2008, shall be properly pre-registered by the Supplier or by the previous suppliers even if the manufacturer or EU-importer has ceased to manufacture or EU-import the substance by the 1st of December 2008.
- he will inform ABUS as soon as possible and unrequested about products containing substances, which could be classified as "Substance of Very High Concern (SVHC)" according to Article 33 of REACH,
- he undertakes to provide ABUS with a complete listing of all SVHC's included in all products and their packaging to be delivered to ABUS. The listing should consist of (by substance and by product): chemical name, CAS number (Chemical Abstract System), weight of product, weights of each substance and percentage (by weight) of each substance in the final product and the main purpose of the substance in the product or its packaging. Instructions on how to use products safely without impact on human health and the environment are to be delivered as well.
- he provides ABUS, if so requested, with information of all substances used in the products and their packaging to be delivered to the Buyer such as: chemical name, CAS number and weight and the percentage (by weight) of the substance in the final product. The data is required to fulfill ABUS' duties towards the authorities and clients.
- he undertakes to follow up the REACH SVHC candidate list, which the ECHA (European Chemicals Agency) published for the first time on October 29, 2008 on the ECHA website, and to inform ABUS without any delay about any changes in the contents of the products or their packaging relevant to REACH Regulation,
- he will immediately take such measures, that his products are in compliance with the latest changes in the SVHC list,
- he will short-term substitute substances which are classified as "Substance of Very High Concern (SVHC)" and
